

AUTHORIZED INTERNET RESELLER AGREEMENT

This Lumitec Internet Reseller Agreement executed between the parties (the "Agreement") is made by and between Lumitec, LLC, a Florida limited liability company with principal offices at 1055 SW 15th Avenue, Suite 7, Delray Beach, FL 33444 ("Lumitec"), and the authorized internet reseller which has executed this Agreement ("Reseller"). The "Effective Date" is the date on which the Agreement is executed by the Parties. Lumitec and Reseller are each sometimes referred to herein as a "party" or collectively as the "parties." The parties agree as follows:

- 1. <u>Authorization of Online Sales</u>. Lumitec grants to the Reseller and the Reseller accepts the non-exclusive right to fulfill orders and to market, sell, and distribute the Products listed in Schedule A to Consumers located in the United States of America (the "Territory") solely on the Internet URL locations listed on their Internet Reseller Profile ("Authorized Websites") attached hereto as Schedule B and approved by Lumitec;
- <u>Third-Party Internet Marketplace Sales</u>. Reseller is prohibited from selling the Products on Internet marketplaces including, but not limited to, Amazon, Walmart, eBay, Target, Rakuten, Sears, unless Reseller obtains prior written permission from Lumitec authorizing them to sell on specific Internet Marketplaces and under specific seller names. Lumitec may revoke or amend this Agreement by sending notice to Reseller and such revocation or amendment shall become effective upon delivery of such notice;
- 3. <u>**Transshipping**</u>. Resellers shall not transship Products. Specifically, Resellers shall not sell or transfer any Products to any person or entity for resale. Resellers agree to restrict, cease, or limit the sale of Products to anyone at the request of Lumitec;
- 4. <u>Geographic Sales Boundary</u>. Resellers may only sell and advertise for sale the Products within the United States. Lumitec hereby expressly prohibits Resellers from soliciting or consummating sales outside of the United States;
- 5. **<u>Reseller Obligations.</u>** During the Term of this Agreement, Reseller shall:
 - a. use its best efforts to display, promote, demonstrate, market, and sell the Products;
 - b. comply with additional terms of sale as specified by Lumitec from time to time in Lumitec's sole discretion;
 - c. not sell or otherwise promote, advertise, market, or provide the Products outside of the Territory;
 - d. not obscure or alter in any fashion the serial number on any Product or its packaging;
 - e. promptly respond to all communications and correspondence from Lumitec and to comply with all reasonable guidelines, policies, and procedures issued by Lumitec from time-to-time;
 - f. conduct and always maintain its operation in compliance with all applicable Federal and State Laws and regulations; and
 - g. not engage in any unfair trade practices.

6. Intellectual Property.

- a. <u>Grant.</u> Reseller is granted a limited, non-exclusive, non-transferable, revocable license to use the Licensed Intellectual Property identified on Schedule C ("Licensed IP" to include the Lumitec name and logos) for the sole purpose of advertising and promoting the sale of Products within the Territory to Consumers.
- b. <u>Restrictions and Limitations.</u>



- i. Reseller shall ensure that the Licensed IP is: (a) used in conjunction with the ® or TM designations as directed by Lumitec; (b) not modified in any manner without the prior written consent of Lumitec; (c) used alone without any other terms, marks, or designs which may detract from the Licensed IP; (d) not used in any way that disparages the Licensed IP or Lumitec; and (e) displayed according to specifications which Lumitec may provide from time to time.
- ii. Reseller shall have no right, title, or interest in the Licensed IP. All use of the Licensed IP and the goodwill associated therewith shall inure to the benefit of Lumitec. Reseller shall not do anything inconsistent with Lumitec's ownership of the Licensed IP, including, but not limited to, using, causing or permitting another party to use the Licensed IP as any part of a uniform resource locator ("URL"), metadata tag, or as a keyword or search engine term. Reseller shall not, during the Term or thereafter, challenge the validity of the Licensed IP or Lumitec's title to or rights in the Licensed IP.
- iii. Reseller will not (i) use the Licensed IP as part of its business or trade name; (ii) use the Licensed IP or any part of Lumitec or Product brand names, or any other trademarks or trade names of Lumitec and its subsidiaries and affiliates, or any simulation thereof except as expressly described above; or (iii) register or apply for registration of any Licensed IP or any other trademark that incorporates Licensed IP in whole or in confusingly similar part. Without limiting the foregoing, Lumitec may at any time and for any reason, restrict or terminate the rights granted in this Section 6. The rights granted in this Section 6 shall not preclude or limit the rights of Lumitec, or any other distributor appointed by Lumitec, to use the Licensed IP within the Territory in any way.
- iv. Upon termination of this Agreement, Reseller shall immediately discontinue and abandon its use of the Licensed IP, shall cease to advertise or represent itself as an Authorized Lumitec Reseller, and shall cease to market, advertise, offer to sell, and/or sell the Products. Reseller must promptly return to Lumitec all Confidential Information, including, but not limited to, all documents and information concerning prices, marketing, advertising, and promotional activities.
- 7. Paid Search Advertising. Reseller shall not, directly or indirectly, without Lumitec's prior written consent, which may be granted or withheld in Lumitec's sole discretion, engage in any paid search advertising, search engine marketing, or other online advertising or marketing campaign that uses the Licensed IP or any word or phrase that is confusingly similar to the Licensed IP (including any variation or misspelling) as a standalone search term or keyword. Reseller must set the Licensed IP as a negative exact match or negative keywords. Any paid search advertising, search engine marketing, or similar online advertising or marketing campaign by Reseller must use the Licensed IP combined with a descriptive or generic term or phrase related to the Products and shall not identify Products unavailable for purchase from Reseller, or direct consumers to a website that does not sell Products, or use terms like "official" or "original" or other words and phrases that are misleading or inaccurate. Further, Reseller's online advertising or marketing campaigns shall be consistent with the high standards, value, reputation, and prestige associated with the Products and the Licensed IP. In all cases, Lumitec will make the final determination in its sole discretion as to whether a particular use of Licensed IP in online advertising or marketing campaigns is permissible.
- 8. <u>Sales Practices</u>. Reseller shall conduct their business in a reasonable, lawful and ethical manner at all times and shall neither engage in any deceptive, misleading, or unethical practices or advertising at any time; nor make any warranties or representations concerning the Products except as expressly authorized by Lumitec. Resellers shall comply with all applicable laws, rules, regulations, and policies related to the advertising, sale, and marketing of the Products.
- 9. <u>Quality Controls</u>. Reseller shall comply with all quality control standards, including, but not limited to, advertising, storage, and shipping requirements, as announced from time to time by Lumitec;
- 10. <u>Warranty</u>. Lumitec makes certain limited warranties regarding the Products set forth in Lumitec's Product Warranty found at <u>https://www.lumiteclighting.com/support-center/warranty-claim.html</u> (the "Lumitec



Product Warranty"). The Lumitec Product Warranty in its entirety (including the conditions, qualifications, and limitations provided therein) is incorporated into and made a part of this Agreement by this reference. Lumitec WARRANTIES DO NOT EXTEND TO PRODUCTS OBTAINED AND SOLD BY UNAUTHORIZED RESELLERS OR TO PRODUCTS WHICH LUMITEC CONSIDERS ALTERED.

- 11. <u>WARRANTY DISCLAIMER</u>. EXCEPT FOR THE LUMITEC PRODUCT WARRANTY, NEITHER LUMITEC NOR ANY PERSON ON LUMITEC'S BEHALF HAS MADE OR MAKES FOR RESELLER'S OR CONSUMER'S BENEFIT ANY EXPRESS OR IMPLIED REPRESENTATION OR WARRANTY WHATSOEVER, INCLUDING ANY WARRANTIES OF: (i) MERCHANTABILITY; (ii) FITNESS FOR A PARTICULAR PURPOSE; (iii) TITLE; OR (iv) NON-INFRINGEMENT; WHETHER ARISING BY LAW, COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE OF TRADE OR OTHERWISE, ALL OF WHICH ARE EXPRESSLY DISCLAIMED. RESELLER ACKNOWLEDGES THAT IT HAS NOT RELIED ON ANY REPRESENTATION OR WARRANTY MADE BY LUMITEC, OR ANY OTHER PERSON ON LUMITEC'S BEHALF.
- 12. <u>Service</u>. Reseller shall provide the highest levels of customer service. Reseller and its sales personnel shall be familiar with all Products and must obtain sufficient product knowledge to advise customers on the selection of the Products, as well as any applicable warranty, guarantee, or return policy.
- 13. **Product Packaging**. Reseller shall sell Products in their original packaging. Relabeling, repackaging, bundling and other alterations are not permitted without written permission from Lumitec. Tampering with, defacing, or otherwise altering any serial number, UPC code, batch or lot code, or other identifying information on products or their packaging is prohibited. Resellers shall not remove, translate, or modify the contents of any label or literature on or accompanying the products.
- 14. <u>Unilateral Pricing Policy</u>. Reseller is informed of Lumitec's Unilateral Pricing Policy as it applies to the advertisement for sale of the Products from Reseller to consumers in the United States. There is no agreement, express or implied, between Lumitec and Reseller with respect to the advertised or resale pricing of the Products. If any director, officer, employee, representative, or other agent of Lumitec tries to coerce resellers to agree to the price at which resellers advertise or resell the Products, such action shall be considered void, unauthorized, and without effect and resellers shall promptly notify Lumitec at BrandProtection@Lumiteclighting.com
- 15. <u>Term.</u> The ("Term") of this Agreement shall begin on the Effective Date and, unless sooner terminated as provided in Section 16, continue in full force and effect for one (1) year from the Effective Date. This Agreement will automatically renew for consecutive one (1) year terms thereafter.
- 16. <u>Termination</u>. Lumitec, in its sole and absolute discretion, may terminate this Agreement in whole at any time upon written notice. Lumitec may revoke its approval for Reseller to market and sell Products at one or all of the Authorized Websites, and Reseller must cease all such marketing and sales immediately on the applicable Authorized Website(s) upon receiving notice of such termination. Upon termination of approval to market and sell Products at one or more Authorized Websites, Reseller's authorization to use Licensed IP on such Authorized Websites will be revoked without further action required by Lumitec. On termination of Reseller's status as an Authorized Reseller, this Agreement shall terminate automatically, and Reseller shall immediately cease all marketing and sales of Products on the Authorized Websites.
- 17. <u>Availability of Injunctive Relief</u>. If there is a breach or threatened breach of Sections 1 (Authorization of Online Sales), 6 (Intellectual Property), or 16 (Termination) of this Agreement, it is agreed and understood that Lumitec will have no adequate remedy in money or other damages and accordingly shall be entitled to injunctive relief and other equitable remedies; provided, however, no specification in this Agreement of any particular remedy shall be construed as a waiver or prohibition of any other remedies in the event of a breach or threatened breach of this Agreement. No failure, refusal, neglect, delay, waiver, forbearance, or omission by Lumitec to exercise any right(s) herein or to insist upon full compliance by Reseller with Reseller's obligations herein shall constitute a waiver of any provision herein or otherwise limit Lumitec's right to fully



enforce any or all provisions and parts thereof. Reseller expressly submits to personal jurisdiction and venue in the federal or state courts of record in Palm Beach County, Florida for any action or proceeding for injunctive relief.

18. <u>Indemnification</u>. Except as otherwise provided herein, Reseller shall, and hereby does, indemnify, defend, save and hold harmless Lumitec, and its directors, officers, employees, shareholders, members, partners, counsel, auditors, accountants, agents, advisors and all other representatives and each of the heirs, executors, successors and assigns of any of the foregoing, from and against any and all losses, liabilities, obligations, actions, causes of actions, suits, debts, dues, sums of money, accounts, reckonings, bonds, bills, covenants, contracts, controversies, agreements, promises, variances, trespasses, damages, judgments, executions, claims, and demands whatsoever, in law, admiralty, or equity, known or unknown of any kind to the extent they are caused by, arise from, or are incurred in connection with (a) any breach of, or failure to perform, any term, covenant or condition in the Agreement by Reseller, or (b) the negligence or willful misconduct of Reseller or its officers, employees, agents or contractors.

19. Miscellaneous

- a. *Modification.* Lumitec reserves the right to update, amend or modify this Agreement upon written notice to Reseller. Unless otherwise provided, such amendments will take effect immediately and Reseller's continued use, advertising, offering for sale, or sale of the Products on the Authorized Websites following notice of the amendments will be deemed Reseller's acceptance of the amendments.
- b. *Waiver*. No waiver of any breach of any provision of this Agreement shall constitute a waiver of any prior, concurrent, or subsequent breach of the same or any other provisions hereof, nor shall it constitute a course of dealing and no waiver shall be effective unless made in writing.
- c. *Severability*. If any provision of this Agreement is held contrary to law, the remaining provisions shall remain valid.
- d. *Assignment.* Reseller may not assign this Agreement without the prior written consent of Lumitec. Subject to the foregoing, this Agreement shall bind and inure to the benefit of the Parties and their respective successors and assigns.
- e. *Entire Agreement.* This Agreement, the terms and their attachments, if any, constitute the entire agreement between the Parties regarding the contemplated transactions and supersedes all prior agreements and understandings between the Parties relating to the sale of the Products online.
- f. *Counterparts.* This Agreement may be executed in any number of counterparts, each of which shall be an original, but all of which together shall constitute one instrument.
- g. *Governing Law.* The terms of this Agreement and any dispute arising under it shall be governed by, construed, and enforced in accordance with the laws of Florida, without regard to its choice of law rules. Reseller expressly submits to personal jurisdiction and venue in the federal or state courts of record in Palm Beach County, Florida for any action or proceeding with respect to this Agreement or any dispute arising under it.
- h. *Confidentiality*. This Agreement, and its attachments, if any, constitute confidential, proprietary information of Lumitec and shall not be used for any purpose other than the authorized advertising and sale of the Products nor disclosed to any third party without the prior written consent of Lumitec.
- i. *Survival.* The following provisions shall survive the termination of this Agreement: Section 6 (Intellectual Property); Section 18 (Indemnification); Section 19(g) (Governing Law); Section 19(h) (Confidentiality); Section 19(i) (Survival).

The Parties have caused this Lumitec Authorized Online Reseller Agreement to be executed in their respective names by their duly authorized representatives.
